

## **Naatsis'aaan (Navajo Mountain) Chapter-AZ House Wire Project**

### **Request for Proposals**

#### **SEEKING LICENSE ELECTRICIAN – Proposals accepted between 03/12/18 to 03/30/18**

Naatsis'aaan Chapter is strictly mandated to work in compliance with the Five Management System proclaimed by Title 26, Navajo Nation Code to ensure fiscal accountability. Currently, Naatsis'aaan Chapter is requesting for Proposals from license electrician contractors to work with the Chapter to provide services for 17 community members' residential units. These 17 residential units are scattered within the Rainbow Lodge Plateau, Arizona portion of Naatsis'aaan.

Homes are about 3 decades old and will need to be connected to electric utility source. Most houses are wired and requires inspection, and to be tested to make sure electrical circuits are in working order. And the Meter Loops are upgraded & Recertified to the current NEC code and complies with Navajo Tribal Utility Authority (NTUA). NTUA is a sole source provider for Naatsis'aaan.

#### **PROPOSED SCOPE OF WORK**

- Adhere to safety procedures
- Provide supplies and materials
- Transport and secure materials and supplies for project
- Assemble, install, test, and maintain electrical wiring, equipment, appliances, apparatus, and fixtures
- Connect wires to circuit breakers, transformers, or other components
- Inspect electrical systems, equipment, and components to identify hazards, defects, and the need for adjustment for repair, and to ensure compliance with codes
- Advise management on whether continued operation of equipment would be hazardous
- Test electrical systems and continuity of circuits in electrical wiring, equipment, and fixtures, using testing devices such as ohmmeters, voltmeters, and amp meter, and to ensure compatibility and safety of system
- Plan layout and installation of electrical wiring, equipment and fixtures, based on job specifications and NTUA codes
- Make sure the meter loops are completed per NTUA specifications
- Inspect and update the service entrance status
- Provide Certificate of Affidavit for homes wired in accordance with NEC and NTUA specification

#### **REQUIREMENTS**

- Resume
- Must possess updated contracting electrical license
- Must provide copy of insurance certificates: workers' compensation and general liability insurance. Must meet the insurance requirement by Navajo Risk Management Dept.
- Attend a mandatory site visitation to the homes
